Legal grounds for the processing of personal data are formed by Article 6 section 1(b) and (f) of the General Data Protection Regulation of the European Parliament and of the Council of 27 April 2016 [GDPR] (EU OJ L 2016.119.1) – processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract or for the purposes of the legitimate interests pursued by the controller.
5. Your personal data will be stored until the expiration of the time limit for claims resulting from the conclusion of the contract or the performance of other legal obligations imposed of the controller.
6. You have the right to access your data at any time, rectify, delete or limit processing, obtain a copy of the data, object to the processing of personal data, the right to transfer the data and the right to file a complaint with the President of the Office for Personal Data Protection.

 - entities acting as intermediaries in transactions concluded by GSK Industry Spółka z o.o.;
 - subcontractors;
 - entities:
 - providing advisory, consulting, audit or IT services;

 - other entities whose participation is necessary for the fulfilment of obligations imposed on GSK Industry Spółka z o.o., resulting either from the contract concluded – forming the grounds for the
